Notable projects included a ballistic building range, demolitions projects, heavy drop rig facility, brigade barracks and operations complex, and Pope Airfield apron extension. In addition, Pannkuk has extensive experience with mold remediation, HVAC upgrades and fire damage repair. Pannkuk's responsibilities with USACE encompassed more than 35 major construction projects and a budget of \$900 million. He also served as a company commander of the headquarters and support company for the 46th Engineer Battalion in Fort Polk, LA and trained and prepared a 300-man unit for deployment to Iraq.

In 2005, Pannkuk resigned from the military and joined W.G. Yates & Sons Construction Company in Jacksonville, NC. Here, he acted as a project manager for three 20-floor concrete frame luxury condominiums. Pannkuk remained at W.G. Yates & Sons for three years until he joined Andrew Consulting Engineers in 2008 as a Senior Structural Engineer.
